Nomination Process

The selected Black Women of First Distinction will receive her honor during the Juneteenth Celebration of Black Achievers at Governors State University as a component of the Juneteenth Celebration of Black Achievers Gala. The Black Woman of First Distinction will also be displayed as a Black Women of First Distinction showcased in the Illinois Black Hall of Fame. Should your nominee be selected for this honor, you will be notified with an acceptance letter during the first week of ______ with follow-up requirements. Please know that the nominator will serve as the main line of contact

and will be responsible for submitting timely all requested information on behalf of the Black Woman of First Distinction.

Note: Nomination may be made posthumously on behalf of relative, corporation, organization and/or nonprofit organization.



NOMINEE REQUIREMENTS

The nominee for Black Women of First Distinction must have been a resident of Illinois for an unspecified period. Must be able to prove the validity of the First Distinction and the area in which the First Distinction was acquired. Must assist the Nominator by providing all requested information requested but not limited to the following:

- Must have met the criterial of having a First Distinction for a notable period
- Must have served as a positive role model for other aspiring women and girls
- Must sign and return Media Release Form
- Must provide a professional Image that can be used for promotional purposes due on or before ______
- Must provide Biographical Narrative substantiating your First Distinction noted on the Application Form due on or ______
- Must provide a Typewritten 200-word (more or less) inspirational message to girls that will inspire them to Dream Big Dreams due on or before ______
- Must provide a 3 to 5 Minute Introductory Video to include facts denoting the First Distinction achievement status due on or before
- Must provide the Nominator with a list of guests to solicit Congratulatory Remarks as well as
 a guest list to attend the Juneteenth _____ Gala by _____
- Must purchase a Camera-Ready Heritage Award (\$1,500 Value) to be included in the Souvenir Advertisement Book due ______
- Must purchase Black Women of First Distinction VIP Reception Package \$2,000 Value with\$1,000.00 to accompany the application on or before _____.
- Must assist the nominator in adhering to all timelines and requested item

NOMINATOR REQUIREMENTS

- Must agree to serve as the main point of contact on behalf of the Black Woman of First Distinction.
- Must be able to verify and document that the nominee is or has been a resident of the state of Illinois for a period during her First Distinction acquisition.
- Must be able to verify that the nominee has made a First Distinction at the local, regional, state, or national level.
- Must be able to validate the nominee's achievements that reflect enduring value over time, where she has been the initiator of first change.
- Must submit all nomination information according to requested dates and timelines.
- Must nominate only one Black Woman of First Distinction per calendar year.
- Must be aware that nomination does not guarantee acceptance until officially qualified and officially notified.
- Must submit completed application with all accompanying requests on or before ______
